#### DRUG DESCRIPTION

Every 100 mL contain

Guaiacol 10 mg
Carbocisteine 20 mg
Piroxicam 2 mg
Excipient c.b.p. 100 mL

# **DOSAGE**

Dairy Cattle and Horses: 1 mL per 66 kg. Sheep and Goats: 0.5 mL per 33 kg.

Swine: 1 mL per 20 kg.

Dogs and Cats: 0.12 mL per 8 kg.

Frequency: Every 24 hours for 5 days according to severity of the problem and according to prescription.
