Do not recommended for the following dog breeds: Collie, Bobtail, Scottish shepherd and their breeds. Do not use in dogs younger than 6 weeks. The use of this product may cause neurologic effect. In case of symptoms by overdose, treat with isotonic electrolytic solutions and a Gaba

antagonist such as pricotoxin 1 to 3 mg total dose according to the size of the dog (small, medium or large)
